Subject: Anti-dumping investigation concerning imports of hardwood plywood originating in the People's Republic of China Pre-disclosure

I refer to the above ongoing investigation initiated by the European Commission on 10 October 2024.

The Commission intends to impose provisional anti-dumping measures on imports of hardwood plywood.

In accordance with Article 19(a) of the legislation in force (¹) the Commission provides information on the planned imposition of provisional measures.
